### Course Overview

Guards who carry firearms in NYS are required to complete a **47 Hour Firearms course** before they can be licensed as an armed security guard. This course includes seven hours of classroom instruction in the Use of Force (NYS Penal Law Art. 35) followed by a written examination, and 40 hours on the firing range followed by weapons qualification. Upon successful completion of this course the guard is issued a training certificate. This certificate must accompany the security guard's registration application when submitted to the Department of State to be issued a NYS Armed Guard registration card. Students MUST attend all days.

Armed guards and all retired law enforcement must also complete an **Annual 8 (Eight) Hour Firearms Training course** which includes three hours of classroom refresher on the Use of Force followed by a written examination, and five hours of weapons qualification which includes a proficiency examination. The guard must complete this course as a prerequisite for renewal of his or her armed guard registration. HR 218 is an additional course and does not exempt former police officers from obtaining an armed guard license.

**Applicants must possess a NYS/NYC Pistol Permit prior to being illegible to take the course and will be required to present it upon attending.**

The course will cover:

- Firearms Safety
- Basic Fundamentals
- Nomenclature
- Use of Physical / Deadly Physical Force
- Basic Shooting Exercises
- Barricades
- Dim Light Shooting
- Reloading
- Cover and Concealment Drills
- Range Commands
- Holstering

**Former police officers** who have successfully completed the Basic Course for Police Officers are exempt from most security guard training requirements for ten years after retirement. However, armed security guard applicants who are former police officers, and who completed initial firearms training more than one year before becoming employed as an armed security guard, must complete the 8 Hour Annual Course for Armed Security Guards (firearms). Completion of annual firearms requalification within twelve months of the date of application does not satisfy this requirement. Further, all former police officers who have been retired for more than ten years, must additionally complete the 8 Hour Annual In-Service Training Course for Security Guards.

### **Admission**

Courses are open to all personnel seeking positions in Armed Security provided they **possess a NYS/ NYC Pistol Permit prior to being illegible to take the course and will be required to present it upon attending.** This course covers the minimum requirements, for achievement of an Armed Security Officer's license in the State of NY.

### **Mandatory Attire**

Jeans, BDUs or Duty uniform and a comfortable T-shirt.

Students must bring their own firearm (pending license students may rent), 500+ rounds of ammo, ear and eye protection and own leather gear (duty belt, ammo pouches, holster).
