Course Overview

Today's Police/Security experts are challenged with situations that were only observed in Hollywood movies and third world countries. Today in this post Columbine era, we continue to see our youth get gunned down, not in the streets, but in a place that, growing up, was an area that society considered hands off to violence, guns etc. our public schools. The internet has allowed children under the age of 15 to be educated in fields of weapons, explosives and ammunition, some training the local police officer would not receive in a twenty year career. Combating these issues is an on-going block of training that is essential to safety of the students and faculty in every school.

The purpose of this course is to engage attendees the awareness of the ever growing threats surrounding our children's daily lives and how to implement a plan to stop such threats, and to engage an individual or a group that is actively or threatens to, take lives within the walls of our schools. Engagement is the key factor to any active shooter. This course will be taught utilizing classroom lectures, and practical field exercises. The training course will consist of eight hour days usually taught during the day, however some practical exercise may be taught in the evening hours. This course will include the following.

- The active shooter who are they
- Weapons familiarization shotgun, 9mm, MP5 AR15
- The use of the ballistic shields (Baker Bat Shields)
- Familiarization of the equipment, helmets, Kevlar vest etc.
- Practical exercises, entering the building, cover and concealment, room clearing, slicing the pie
- Tactical teams, two men, four men six men
- Removing and stopping the threat
