



## **TACTICAL HANDGUN/CARBINE/SHOTGUN/RIFLE COURSE**

### **Course Overview**

Police/Security departments throughout our nation are restricted to monetary budgets that require administrators to make cuts to these forced budgets. The first of which come from their training divisions. This process forces such administrators to seek the "so called" lowest bid. Unfortunately, the first responders suffer when they are faced with subjects who not only have more powerful weapons, but their training levels are much more superior. This process encourages police and security departments to look outside their commands, for training, that will allow their officers to maintain a training level that will hopefully be equal or higher than the ensuing imminent threat of danger. This course will introduce weapons such as the M4 (AR15) rifle, MP5 tactical assault weapon and will introduce hands on tactical weapons training for the Glock 17, 19 and 26.

The purpose of this course is to engage attendees in awareness of the ever-growing threats surrounding our daily lives and how to implement and maintain control within an environment that is constantly in motion. Awareness is the key factor in determining and engaging any threat that is present. This course will cover a host of tactical situations that will increase the officer confidence and ability to keep that will to survive when faced with circumstances that may escalate to a deadly physical force contest. The course will be taught utilizing classroom lectures and practical range exercises. The training days will consist of eight- hour days, usually taught during the day, however some night combat sessions, obviously will be held in the evening hours. The course content will include the following:

- Re-familiarization of the Glock 17,19 and 26
- Safety lectures
- Clearance drills
- Re- familiarization of the shotgun
- Shotgun loading and unloading
- Shotgun Combat loading
- Introduction to the M4 (AR15) rifle
- Combat loading of M4
- Introduction to the MP5 Assault/Combat weapon
- MP5 Combat loading and clearance drills
- Tactical Drills 9mm
- Tactical drills shotgun
- Combat shooting 9mm and shotgun
- Weapon retention
- Team clearance drills
- Close quarter combat drills
- High and Low Threat Scenarios
- Night combat shooting
- Cover and concealment drills

### **Admission**

Courses are restricted to active or retired law enforcement, military personnel, qualified civilian security professionals and students in an accredited academic institution. All courses are hands on and involve academic as well as practical application. Trainees must provide a copy of their official identification. Each trainee must be in good physical health and not possess any medical conditions that would prohibit the trainee from strenuous activity.
